## PRESIDENT'S ADDRESS


My wife truly enjoys her foreign language lessons. It's her passion. She appreciates the opportunity to learn about her ancestral customs and the history of her heritage. Despite her professional and personal obligations, she devotes ample time each week to master the assignments, complete her homework, and keep pace with the class. She expects no increase in her salary, nor more frequent promotions at her office. We rearrange our family schedule to accommodate her class schedule. Her enthusiastic investment in time and effort toward this endeavor is obvious.

The camaraderie she has made within her classmates is invaluable to her, including that with her teacher. He is brilliant—an informal scholar, if you will. His only employment is private teaching. He belongs to no school district, nor is he appointed to any university faculty. He can recall the best supporting actor in any movie, any year you choose. He is multilingual and is a living encyclopedia of world history. He once came to the aid of an unfortunate immigrant who suffered from a complex dental problem. He translated her treatment history for her new dentist, asked me for guidance, and before long I could tell he was more fluent in dental nomenclature than many of the second year dental students I've known. It's a union of many forming one, comprising a final product—an organization—much bigger than any individual alone.



This year, as the Angle Society completes its 100th year as a unique fraternity of individuals driven by a quest for fulfillment, we fully accept the fact that our membership in this esteemed organization does not earn us any more financial success nor accolades than simple membership in our local dental societies. We've all found that many of our dental—and orthodontic—colleagues cannot define what this unpretentious society even stands for. Yet we know that the gifts of camaraderie and enrichment, the exchange of ideas, and the friendship we share with each other cannot be remunerated by more case starts this year or an accelerated promotion next year at the program in which we teach.

My wife and her teacher have found the prized secret to fulfillment. So have we as members of this glorious society. We are so fortunate to be aboard and to realize that the allure of fulfillment can be powerful motivation indeed.

In her infinite wisdom, Heller Keller, blind and deaf since birth, said, "The best and most beautiful things in the world cannot be seen or even touched. They must be felt with the heart."

What other motivation do you and I need to be part of this beloved Society? ■



## IN MEMORIAM

### DR. SHELDON PECK, (1941-2021)

Dear Members of the Angle Society,

It is with the heaviest of hearts that I convey the news of the passing of our beloved colleague and friend Sheldon Peck this past weekend, caused by a congestive heart failure. We knew his health was failing, but nothing had prepared us for the suddenness of this tremendous event.

We will always remember Sheldon's wit, tolerance for diversity and love for variety in our Angle East membership. Sheldon was the ultimate Mentor and generous Patron of the international orthodontic community, the splendid backbone of our legacy as Anglers.

I always wondered if Sheldon was maintaining his aplomb by wearing earplugs, when surrounded by a bunch of energetic young colleagues in loud philosophical discussions regarding the future of orthodontics, over lunches he regularly hosted at the Saint Botolph Club in Boston.


Sheldon's seraphic smile had a Mona Lisa quality to it, through which one could get just a small glimpse of the towering intellect hiding in the background.

Sheldon knew how to live life to the fullest, professionally and personally. He was a philanthropist and an avid art collector, specializing in drawings by Rembrandt, 17th-century Flemish and Dutch artists, and rare books.

In short, Sheldon Peck had reached the full and well deserved status of "forever young".

Sheldon Peck was born in New York City in 1941. He had earned his B.S. Degree and D.D.S. Degree at the University of North Carolina at Chapel Hill, and there, as a symptom of a future brilliant career as rarities collector, he became a member of any existing Honor Society (Phi Eta Sigma, Alpha Epsilon Delta, Phi Beta Kappa, Omicron Kappa Upsilon). He went on to complete his Postgraduate orthodontic education at Boston University Medical Center under Margolis, and then received the 1967 Tweed Foundation Research Award.

For many years Sheldon was a dedicated member of the teaching staff both at B.U. and at the Harvard School of Dental Medicine. At Harvard, he held the title of Clinical Professors of Developmental Biology. Sheldon also maintained a successful private





practice in Newton, MA, alongside his beloved late wife and most esteemed Angler, Leena Peck. Together, Sheldon and Leena were a formidable team.

Sheldon served in innumerable university and professional societies committees, published innumerable

articles and book chapters, not only on orthodontic topics but also on art, contributed to research as PI or Co-PI in projects on craniofacial form, dental anomalies, skeletal dysmorphology, tooth shape variations, facial aging. A truly gifted and entertaining speaker, he lectured extensively, nationally and internationally, and delivered the Strang Memorial Lecture at the NESO in 1985, the E.H. Angle Memorial Lecture at the Biennial Meeting in Quebec in 2007, the E. H. Angle Lecture at the AAO meeting in 2009, the Keynote Lecture at the 85th Congress of the European Society in Helsinki in 2009 and the Mershon Lecture at the 2016 AAO annual session. That same year, he delivered the Sheldon Friel Memorial lecture at the European Congress of the European Orthodontic Society in Stockholm, Sweden. Sheldon served on several editorial boards: AJODO, The Angle Orthodontist, Seminars in Orthodontics, JDR, JCO, JADA, and The Journal of the History of Dentistry. He was a mentor for several students' theses, and collaborated with international researchers on an extraordinary variety of topics.

Sheldon dedicated his life to orthodontics and especially to the Angle East and the EHASO, which he considered "his second home". He served as our Angle East President in 1982-1983, as EHASO Director in 1988-1990, and was EHASO Secretary for 14 years, then Secretary Emeritus, and then Historian, and EHASO Vice-President in 1993. The EHASO awarded him the Research Prize for Excellence in published orthodontic research, and in 2007 he received the Angle East Harvey Peck Memorial Awards for Excellence in Orthodontics, then in 2009 the Distinguished Service Award.

Sheldon was also very proud of having been the recipient of the 2011 Hayden-Harris Award by the American Academy of the History of Dentistry. He also received the ABO Ketcham Memorial Award in 2017.

A colleague of Shel's stature deserves to be honored by farewells written by the best and brightest of our Society, members who have walked the Angle Society path with him.

I am sure many of you will contribute a few words following this initial message, that I wanted to send as soon as possible to reach our entire membership.

The Peck family held a private burial on Thursday April 22, 2021 at the Beit Olam Cemetery in Wayland, MA. Attendance to the ceremony was unfortunately limited by Covid-19 restrictions.

## TRIBUTE TO DR. SHELDON PECK

Sheldon Peck possessed that rare ability to engender anyone with whom he conversed to feel on top of the world. It was never about him, unless asked. He epitomized an effort toward perfection, with science and art blended with his brilliance. Dinners and meetings, AAO or EHASO, with Shelly chimed to an upbeat and learning experience. Sheldon knew everyone by name, and their interests. He never sheltered ideas in a cave like Plato warned against, and missed the truth for shadows on the wall. He could critique any subject based on science and art. Dr. Peck inspired those that moved through his life. Our times together with the

American Journal of Orthodontics & Dentofacial Orthopedics were smooth and effective. He embodied qualities of leadership with grace. Sheldon understood the bridge between art and science, subjective and objective evaluation. He is a great loss to humanity, with his determination to seek the truth and his love for history. Sheldon Peck searched for solutions without bias; he used logic when needed, and all five senses when subjective feelings were found essential.





the Board of Directors, and even our journal lends its hand as needed. The contribution of our component society is significant. The connection between the AAOF and Angle North Atlantic is also a two-way street.

In the year of the pandemic, the Foundation was able to bring many changes and programs. It was principally due to not traveling. We had time. The AAO and AAOF worked synchronously to stay in touch with our members and create new programs. The AAOF is now the fundraising arm for the AAO, no longer a distant relative. The foundation administers programs such as Donated Orthodontic Services (DOS) and Disaster Relief Fund (DRF) in much more significant numbers than before. The AAOF provided gifts for residents to attend the Annual Session. The newly created Rapid Assessment of Evidence (RAE) program permits any AAO member to inquire about the validity of a manufacturer's claim. The AAOF implemented Accelerated Funding of Proposals (AFP), a process that bypasses the annual grant submission cycle and funds critically important grant applications within six weeks.

The AAOF seeks to support a wide range of research of interest to the specialty. In addition to potential contributions to the sci-





ence of orthodontics, the AAOF encourages research about the business of orthodontic practice, the creation of novel technologies and software, the use of artificial intelligence, and other contemporary issues. Grant proposals that include intercollegiate collaboration, as well as inventions and innovations unique to orthodontics, are of particular interest to the AAOF

The academic culture of the North Atlantic Component is unique. All our members who have served on the AAOF, and its committees, would understand the Foundation's need for grassroots support. The easiest way is by joining the Century Club. A new website is coming this year."

Ahmad Hamdan (Amman, Jordan) received the Ad Eundem Fellowship (FFDRCSI) from the Royal College of Surgeons of Ireland for his "outstanding contributions to Dentistry." Congratulations, Dean Hamdan, for this well-deserved and prestigious award!

### 2021 Angle East Meeting and 2021 EHASO Biennial Meeting







Secondly, I got to play a lot more golf and walked, carrying my golf bag so I got a lot of good exercise at the same time. Thirdly, I became a better cook and spent time with my mother, Dr. Annie Chin Siu, who is my role model and inspiration in so many ways: excellent orthodontist, wonderful caring mother and outstanding thoughtful person.

“I’ve said to many patients and parents that one of the few benefits of Covid-19 is that because people are at home more, I’m seeing more rapid progress in our patients that are wearing compliance dependent appliances like headgears and elastics. For headgears, our pre-Covid recommendation was to NOT wear it to school, during sports, or when out socializing with friends, but

to wear it when they were in the house doing homework, watching television, playing computer games and while they were sleeping. So basically, 12-14 hours per day of wear. During our Covid-19 isolation times, I have encouraged our patients to wear it more and believe it or not, many patients actually have listened, and the results have been very satisfying! It's amazing how quickly the teeth move when you have compliant patients!"

"Here are a few of Covid-19 Pandemic positive comments related to personal and office:

1. After returning, staff have definitely been more attentive to wearing PPE: eyewear, masks and face shields. Also, they clean everything, something they might have overlooked or made excuses about in the past.
2. During the shutdown, I was able to get a lot of documents digitized by scanning and shredding personal documents, receipts, patient charts - I am now working on photographing old study models and disposing of them out of my garage.
3. General clean-up and clean-out of things previously hastily stored for a later time.
4. Refocus of priorities - when to say 'yes' or 'no' to being asked to do something big that will clutter or unclutter your life.
5. Time for catching up on responsibilities in volunteer jobs - mainly accounting.
6. Developed new friends via Zoom connections." Milton Chan

"Probably, most human beings on our planet Earth have made some changes in regard to their particular environment and lifestyle as the result of the awareness and impact of the Covid-19 Pandemic. I would like to talk about the changes that I made with my Tokyo office:

1. We made an official LINE SNS (Internet Social Networking Service) account for our patients and parents. They can register with our office LINE account and we respond to their questions and offer them solutions without their need to visit our office.
2. We are now offering the initial orthodontic information for potentially new patients using the Zoom internet (computer/cell phone camera/audio) system.

3. We use the Zoom system mentioned above for the Initial Consultations and Diagnosis. For example, the patients that live in faraway country areas do not like to visit Tokyo or central Yokohama because they are concerned about Covid-19. Being able to make the initial diagnosis via the Zoom system alleviates their concerns.

4. We also hold internet case presentations with other health care providers.

I have held internet meetings well before the Corona Virus (Covid-19) started and many were against internet meetings. However, now some have changed their minds and online consultations are becoming more common. This is one of the minor good effects of the Corona Virus. Finally, the word Corona is very nostalgic for me because Corona, California was the 1st city that I visited in America in 1982 and it is also where I earned my Private Pilot's License! I never could have imagined that the name Corona would become so famous in all of the world!"
