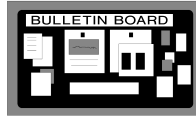

Applications are invited for a full-time confirmation path position of Lecturer/Senior Lecturer in the Department of Oral Rehabilitation within the Faculty of Dentistry, University of Otago, Dunedin, New Zealand.

The Department of Oral Rehabilitation is responsible for teaching the disciplines of Operative Dentistry, Endodontics, Prosthodontics, Biomaterials Science and Dental Technology at undergraduate and postgraduate levels. The appointee should have appropriate qualifications and clinical experience and will be expected to participate in teaching and course development.
